
1. The property subject to this Lien is owned by Thomas H. Campbell and Joy M. Scott Campbell.







"ATTACHMENT"

Part of the Southeast Quarter of Section 5, Township 2 South, Range 7 West, DeSoto County, Mississippi; and more particularly described as follows:

Beginning at a point commonly accepted as the southeast corner of the northwest quarter of said quarter section; thence run south 01° 12' 00" West a distance of 447.76 feet along the west line of the Duckworth property to a point; thence run due west a distance of 208.19 feet to a point; thence run North 64° 50' 13" west a distance of 534.15 feet to a point on the centerline of Tchulahoma Road; thence run northeasterly along said road centerline, a curve to the left with a radius of 416.11 feet, a distance of 521.74 feet to a point on the south line of said northwest quarter of said southeast quarter section, thence run South 84° 24' 47" East a distance of 261.82 feet along said quarter-quarter section line to the Point of Beginning and containing 4.33 acres more or less.
