Work of Heart Ministries hereby serves notice on Colonial Hills Baptist Church a Materialman's and Laborer's Lien under the provisions of 85-7-131, et seq., Mississippi Code of 1972, and hereby notifies the said Colonial Hills Baptist Church, of the claims of Work of Heart Ministries and who, in support thereof, would show and state the following:

1. That Colonial Hills Baptist Church is the owner of the following described land located in DeSoto County, Mississippi, more particularly described as follows:

The 16.70 acres located presently at 7701, Highway 51 North, situated in Section 26 Township 1 South, Range 8 West, Desoto County, Mississippi as per plat thereof recorded in the office of the Chancery Clerk of DeSoto County, Mississippi. **NORTHWEST QUARTER OF SECTION 26**

2. That Colonial Hills Baptist Church contracted with Work of Heart Ministries to provide for construction work on the property described above. That pursuant thereto, Work of Heart Ministries did provide labor and materials for construction on the property described above and that as a result thereof, there is presently due to Work of Heart Ministries the sum of \$13,340.00 which will accrue an additional interest at the highest rate allowed by law from and after the date of this lien filing.
3. That there is unpaid at this time, as shown by the sworn Affidavit of Account of Work of Heart Ministries, marked Exhibit "A", the sum of \$13,340.00, which said sum is presently due and owing and which said sum the said Colonial Hills Baptist Church have refused to pay although requested several times to do so.

Statement for Children's Building Scenic Design
and Construction:

Phase I

Construction and application of approx. 750 square feet of three-dimensional sets and layout of wall murals in Creation Hall in lower preschool area in 6 panels on the days of creation with scripture, opposing wall with the animals of creation, three-dimensional tree to cover video display cabinet, 3 proscenia for classroom entrances (approx. 12' x 8'6") including "sun, Moon and Stars", "Plants and Animals", and "Garden of Eden"

Stories of the Old and New Testaments Hall - includes 2 proscenia for classroom entrances (approx. 12' x 8'6") including "Jonah's Fish", and "David and Goliath", three-dimensional Bible to cover video display cabinet, North side of hall to include stories of Old Testament, South side of hall New Testament from Bethlehem to Second Coming

"Noah's Ark Welcome Station" to wrap around large circular support column with Large and small stuffed animals to surround column with rainbow and cloud painted ceiling

Notes

Hallways and classrooms to be laid out in pencil and permanent marker after walls painted in prescribed colors (see renderings)

Sets and Proscenia all constructed of wood with some sculpted urethane and fiberglass features and attached on wallboard with screws driven into studs, Noah's Ark Welcome Center is a free standing desk surround

Consultation and on-site direction for wall and mural painting included in overall cost for working with volunteer church painters during each week of installation not to exceed 12 hours per week and not on Wednesday's in Pm or Sundays

Includes:

Design and layout of preschool wing with color maquette of 2 lower halls

Does not include:

Actual Painting of halls and interior rooms
