Notice of Withdrawal of Construction Lien

1. The property upon which this construction lien is withdrawn is described as:


Part of the Northwest Quarter of Section 22, Township 3 South, Range 7 West, DeSoto County, Mississippi more particularly described as follows:
Commencing at the intersection of the west line of Section 22, Township 3 South, Range 7 West, DeSoto County, Mississippi, and the centerline of Holly Springs Road, thence South 67 degrees 49'23" East, a distance of 1241.66 feet to the centerline of said road; thence South 1 degree 01'58" East, a distance of 42.61 feet to a 3/8" rebar set in the south line of said road (80' right of way) being the POINT OF BEGINNING; thence South 70 degrees 51' 45" East along said south line, a distance of 361.50 feet to a 3/8" rebar set; thence South 1 degree 01'58" East, a distance of 384.50 feet to a 3/8" rebar set; thence North 70 degrees 51'45" West along said east line, a distance of 361.50 feet to a 3/8" rebar set in the Lynchard east line; thence North 1 degree 01'58" West along said east line, a distance of 384.50 feet to the POINT OF BEGINNING; said described tract containing 3.00 acres, more or less.

2. Nothing herein shall be construed to release any other liens which may have been or may be filed. Nothing herein shall be construed to prevent the lien holder from re-filing a lien against the property described herein in the event that the lien holder should become otherwise entitled to do so by law.
