All of the aforesaid construction materials were furnished by Marble Products and were used in and about the improvement of the afore-described real property for the benefit of the Owner thereof. This Notice of Lien Claim has been filed within the time required according to the laws of the State of Mississippi, and the claimant will take all legal steps to enforce its lien as required by law.

The total amount justly due and owing for construction materials furnished to and delivered to the property, after allowing all just credits and deductions, is the sum of Two Thousand Three Hundred Sixty-Three Dollars and Seventy-Six cents (\$2,363.76), all of which remains due and unpaid.


