KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the United States Department of Agriculture a department of the United States of America acting on behalf of the Rural Housing Service by the undersigned Administrative Program Director, Rural Development pursuant to Public Law 103-354, title II of the Department of Agriculture Reorganization Act, October 10, 1994 and the Federal Agriculture Improvement and Reform Act of 1996, Public Law 104-127, April 4, 1994, and

WHEREAS, the United States Department of Agriculture acting on behalf of the Rural Housing Service by the undersigned Administrative Program Director, Rural Development pursuant to the Housing Act of 1949, or other similar Statute has advanced loan funds which are secured by Real Estate Deeds of Trust, naming the United States acting by and through the Rural Housing Service, successor in interest to the Farmers Home Administration as Beneficiary; and


WHEREAS, the United States of America and the Rural Housing Service through Rural Development as Beneficiary, desire to remove the Trustee named in each such Deed of Trust and as successor as Substitute Trustee:

NOW THEREFORE, by virtue of the powers vested in me as Administrative Program Director of the Mississippi Rural Development acting on behalf of the Rural Housing Service, United States Department of Agriculture, I, Roger S. Roberson, Jr., hereby remove the Trustee previously designated as Trustee or as Substitute Trustee in all Real Estate Deeds of Trust owned or held by the United States acting by and through the Rural Housing Service which are recorded in Desoto County, Mississippi, and I do hereby appoint and designate Curtis B. Breland, Rural Development Area Specialist, of the aforesaid county and State, whose address is 175 Broome Ridge Road, Suite B, Batesville, Mississippi, 38606, as the Substitute Trustee to serve for all purposes. The Substitute Trustee is specifically authorized to foreclose the Deeds of Trust by advertisement and sale at public auction as required by law.

This General Substitution of Trustee is made pursuant to Mississippi Code Section 89-5-45 as amended by Senate Bill 2485 effective July 1, 1983.
