BEFORE ME, *W. E. Davis*, the undersigned Notary Public, personally appeared, Kathleen L. Foster, c/o Post Office Box 530903 Lake Park, Florida 33403, who has placed a **CHOATE LIEN** on the above named **Property** and further states:

1. I, Kathleen Lee Foster, hereby place this **CHOATE LIEN** against the all possessions, assets, private/personal property, and real property, known and unknown, against one Richard Harrison Barrett/Baroni, Sr.
 2. That on or about the 18th of November 1999, Richard Harrison Barrett/Baroni, Sr. did leave Kathleen Lee Foster, his 'legal' wife', to remove himself to live with Adulteress, Angeline Marie Morrison, of Pennsylvania.
