DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, MISHE SIMMONS PATTERSON, of DeSoto County, Mississippi, hereby revoke all powers of attorney heretofore made by me and by these presents do make, constitute and appoint my mother, MICHELLE R. MOYERS, of Nesbit, DeSoto County, Mississippi, as my true and lawful attorney-in-fact, for me and in my name, place and stead to do and perform all things that I could do myself in the transaction of any business of mine, on such terms and in such manner as said attorney-in-fact may deem appropriate including, without limitation, the power and authority to:

1. Seek, authorize and provide for any and all medical needs of my children, Coleman Myles Patterson, a male child, born October 21, 1994, and Morgan Jessica Patterson, a female child, born January 19, 1990.

2. To do any and all acts in my stead as may be demanded or required for the proper care, provision and nuturing of my said children listed above.

3. Make and sign in my name any and all documents necessary to care, provide or otherwise meet the necessary needs of the above referenced children.

4. In accordance with § 87-3-13 of the Mississippi Code of 1972, Annotated, as amended, and as thereafter may be amended, this Durable Power of Attorney shall not be affected by my subsequent disability or incompetence.

5. By way of explanation, I am going to school full time and working full time. My current residence is currently in the home of my mother. The best interests of my children demand that they have a more stable environment with regular dependable loving attention. That my children can get no better care than that of my mother. That my children shall temporarily reside in the home of my mother, whether I reside there or not for an unspecified period of time until I can better provide for them on my own and more free and clear of interference from my ex-husband's complaints. While my children reside with my mother, whether I physically reside at that premises or not, I will pay to my mother \$150.00 weekly to assist with the care of my children.


