KNOW ALL MEN BY THESE PRESENTS: That I, Mary L. Gardner, 5370 Sollie Cove, Horn Lake, Mississippi, SS# 8699, do make, constitute and appoint, W. L. Gardner of 5370 Sollie Cove, Horn Lake, Mississippi, SS# 3013, my true and lawful attorney for me and in my name, place and stead and for my USE AND BENEFIT to ask, demand, sue for, recover, collect, and receive all such sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demands whatsoever as are now, or shall hereafter become due, owing, payable or belonging to me, and have, use and take all lawful ways and means in my name or otherwise for the recovery thereof, by attachments, etc. and to compromise and agree for the same, and acquittances, or other sufficient discharges for the same, for me, in my name, to make, seal and deliver; to bargain, contract, purchase, receive and take lands, tenements, hereditaments and accept the possession of all lands and all deeds and other assurances, in the law, therefore, and to lease, bargain, sell, release, mortgage real and personal property, upon such terms and conditions, as he shall think fit. Also, to bargain and agree for, buy, sell, mortgage, real and personal property, upon such terms and conditions, as she shall think fit. Also, to bargain and agree for, buy, sell, mortgage, and in any manner deal in and with goods, wares, and merchandise, choices in action and other property in possession or in action, and to make, do, and transact all and every kind of business of what nature or kind whatsoever, and, also, for me and in my name, and as my act and deed, to sign, seal, execute, deliver and acknowledge such deeds, leases and assignment of leases, covenants, agreements, mortgages, charter-parties, bills of lading, bills, bonds, notes, receipts, evidences of debts, releases and satisfaction of mortgage, judgments and other debts, and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises.

It is my specific intention that this power of Attorney shall be a Durable Power of Attorney which shall give W. L. Gardner the right to continue functioning as my Power of Attorney in the event that I become mentally unable to manage my affairs or to make any necessary decision on my own part.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that my said attorney, of his substitute or substitutes, shall lawfully do or cause to be done by virtue of these premises.
