**MEMORANDUM OF LEASE**

This MEMORANDUM OF LEASE is executed on November 17, 1999, by **AUTOMATIC LAUNDRY COMPANY, LTD.** ("Lessee"). This Memorandum of Lease is executed to give notice of that certain Lease between Parkway Apartments LTD ("Lessor") and Lessee dated January 15, 1997. 
