LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I Chastitie S. Brim aka Chatitie S. Brim, of Olive Branch, Mississippi, do make, constitute and appoint Joseph J. I INTEND HEREBY THAT MY attorney shall have the same powers over my affairs with respect to the purchase/refinancing of the Property as I myself might personally exercise, and I hereby ratify all lawful acts done by my attorney by virtue hereof.

THIS POWER OF ATTORNEY SHALL not terminate in the event of my disability.
