LIMITED POWER OF ATTORNEY

This Limited Power of Attorney is executed as of November 19, 1999, by COMPANION MORTGAGE CORPORATION, a company having an office at 4435 Main St., Suite 500, Kansas City, Missouri 64111 ("Companion"), appointing as attorney-in-fact FAIRBANKS CAPITAL CORP., a Utah corporation having an office at 3815 South West Temple, Salt Lake City, Utah 84115-4412 ("Fairbanks").

RECITALS:

A. Companion and Fairbanks are parties to that certain Subprime Servicing Agreement (the "Agreement"), dated as of July 1, 1998, pursuant to which Fairbanks, as servicer, will service certain mortgage loans listed in the Mortgage Loan Schedule attached to the Agreement ("Mortgage Loans").

B. In connection with Fairbanks' performance of such functions, Fairbanks has requested that Companion empower Fairbanks to execute certain documents on its behalf as further described herein.

NOW, THEREFORE, the parties agree as follows:

1. Companion hereby appoints Fairbanks as its attorney-in-fact, with full power of substitution, to exercise at any time, in accordance with the Agreement, all or any of the following powers with respect to the Mortgage Loans: (i) to execute on behalf of Companion any documents or instruments necessary to collect payments against, to liquidate or cancel any related mortgage, in accordance with the Agreement, and to otherwise manage and service the Mortgage Loans and related properties in accordance with the Agreement; (ii) to execute documents on behalf of Companion in connection with any bankruptcy or receivership of a related mortgagor; (iii) to execute on behalf of Companion any documents necessary to carry out foreclosure of any mortgaged property securing a Mortgage Loan and (iv) to execute on behalf of Companion any documents and agreements necessary for the offer, listing, closing of sale and conveyance of any related real estate owned ("REO") property. This limited power of attorney is not intended to extend the powers granted to Fairbanks under the Agreement or to allow Fairbanks to take any action with respect to a Mortgage Loan not authorized by the Agreement.

2. Companion represents that any bank, title company or other institution may rely on this Limited Power of Attorney in honoring the acts of Fairbanks hereunder.

3. Fairbanks hereby agrees to indemnify and hold Companion and its directors, officers, employees and agents harmless from and against any and all liabilities, obligations, losses, damages, penalties, actions, judgments, suits, costs, expenses or disbursements of any kind or nature whatsoever incurred by reason or result of or in connection with the exercise by


Fairbanks of the powers granted to it hereunder. The foregoing indemnity shall survive the termination of this Limited Power of Attorney.
