
DURABLE GENERAL POWER OF ATTORNEY

STATE OF TENNESSEE  
COUNTY OF SHELBY

KNOW ALL MEN BY THESE PRESENTS, that I, JOHN B. BRIGMAN, JR., the undersigned, a legal resident of the State of Tennessee, residing at Wesley at Millington-the Towers, 5077 Easley Avenue, Millington, Shelby County, Tennessee 38053, do hereby make, constitute and appoint my son, JOHN KEITH BRIGMAN, 800 Dunlap-Orphanage Road, Brighton, Tennessee 38011, acting as my true and lawful attorney in fact for me and in my name, place, and stead, giving unto my said attorney in fact, JOHN KEITH BRIGMAN, full power to do and perform all and every act that I may legally do through an attorney in fact including the sale of any real property owned by me, in whole or in part, wherever located, and every proper power necessary to carry out the purposes for which this power is granted, and hereby ratifying and affirming that which my said son, acting as my attorney in fact, shall lawfully do or cause to be done by virtue of the power herein conferred upon him. Without limiting the general powers heretofore awarded to my attorney in fact, he is also awarded all powers listed in Section 34-6-109, Tennessee Code Annotated, on the date of execution of this instrument.

In accordance with the Uniform Durable Power of Attorney Act as published in Tennessee Code Annotated, Section 34-6-101, et seq., I declare that I am sui juris as of this date and that I desire and direct that this power of attorney shall not be affected by my subsequent disability or incapacity, it being my intent that the authority conferred herein shall be exercisable by my attorney in fact notwithstanding my subsequent disability or incapacity. This power of attorney shall remain in effect until a recision of same is recorded in the Register's Office, Shelby County, Tennessee.




