

LIMITED POWER OF ATTORNEY

KNOW ALL, that I, Lilla Blanche Sophia Fulmer of 1735 Noe Street, San Fransico, CA 94131, being of sound mind and good health as of this date, do hereby appoint Jane Clark Fulmer of 1535 Carr Avenue, Memphis, TN 38104, my attorney in fact with full power to act on my behalf to:

[1] Receive, deposit, and negotiate any and all, checks, drafts and warrants from The State of Mississippi, the Mississippi Transportation Commission, or any agency or agent thereof of the purchase money paid for the lands, improvements, and all appurtenances thereto situated in Desoto County, Mississippi, as described on Exhibit "A" hereto attached,

[2] Execute all, settlement statements, disclosures, warranty deeds, quitclaim deeds, easements, rights of ways, grants, and licenses as necessary to fully and finally complete the conveyance and sale transaction to the Mississippi Transportation Commission of the lands, improvements, and all appurtenances thereto situated in Desoto County, Mississippi, as described on Exhibit "A" hereto attached.

[3] Execute such rights of way and easements to such third party companies or entities as the Mississippi Transportation Commission may designate, as reasonable and necessary to relocate all utility lines, pipelines or similar service lines as located on the lands as described on Exhibit "A" hereto attached to my remaining, adjoining lands.

This power shall not be limited in any manner or circumstance and shall not be affected by my subsequent disability or incompetence.

All persons shall take notice that they may and shall rely on this Power of Attorney, and that the undersigned does hereby waive any right, title or cause of action against any person or party relying on this Power of Attorney. This Power shall be effective until revoked and may be revoked only by written revocation filed for record only in the Office of The Chancery Clerk of Desoto County, Mississippi.



POWER OF ATTORNEY
TO JANE CLARK FULMER

The following description is based on the Mississippi State Plane Coordinate System West Zone, NAD83(93), grid values, using a scale factor of 0.99976011 and a delta angle of positive (+) 00 degrees 17 minutes 17 seconds as developed for Federal Aid Project Number STP-0031-02(001) [101427/202000] by the Mississippi Department of Transportation

PARCEL 1

Commencing at a Cotton Picker Spindle, identified on the above referenced coordinate system as N 1976934 57, E 2447333 98 found at the Southwest corner of Section 3, Township 2 South, Range 6 West, Desoto County, Mississippi, run thence North 64 Degrees 22 Minutes 51 Seconds East for a distance of 67.75 feet, to a point where the existing East right of way line of Mississippi State Road No. 305 intersects the South line the Arthur Fulmer Jr., Et Al, property as shown on the acquisition maps of Federal Aid Project Number STP-0031-02(001) [101427/202000], said point being 63.20 feet right of the proposed Mississippi State Road No. 305 realignment at station 651+48.55, and being hereinafter referred to as the Point of Beginning;

- Run thence North 00 Degrees 40 Minutes 28 Seconds West along the existing East right of way line of Mississippi State Road No. 305 a distance of 795.67 feet;
