LIMITED POWER OF ATTORNEY

Know all men by these presents, that I, Norma Cazares, the undersigned, do hereby make, constitute and appoint my husband, Roberto Orduno, my true and lawful Attorney-in-Fact, for me and in my name, place and stead, and on my behalf, and for my use and benefit:

To sign on behalf of me, any and all documents in connection with the purchase of the real property municipally numbered and known as 6290 Greenbriar Drive, City of Horn Lake, County of Desoto, State of Mississippi in accordance with and pursuant to the terms of that certain contract for sale and purchase of real estate between Norma Cazares and Roberto Orduno, as Purchaser(s) and Raymond A. Except as to the persons having actual knowledge of a modification or termination of this power of attorney, the recordation of this instrument or a copy hereof, in any land records or other appropriate records shall be conclusive as to the authority of the person designated herein to perform the functions and exercise the powers herein granted as to any such act performed prior to the date a modification or revocation hereof shall have been filed for the record in the appropriate records in the county wherein the land or any part thereof is situated.


