

POWER OF ATTORNEY

Know all men by these presents, that I, PAMELA CURRY, the undersigned, of Shelby County, Tennessee, do hereby make, constitute and appoint JEFFREY CURRY, of Shelby County, Tennessee, my true and lawful attorney in fact for me and in my name, place and stead, and on my behalf, and for my use and benefit;

To sign on behalf of me, individually, any and all documents effecting the purchase of the real property known as Lots 131 and 132, College Hills Subdivision, Olive Branch, MS, and being more particularly described as follows:

This power of attorney shall not be affected by my disability and the authority hereby conferred shall be exercisable notwithstanding my later disability or incapacity or uncertainty as to whether or not I am dead or alive.

Except as to persons having actual knowledge of a modification or termination of his power of attorney, the recordation of this instrument or a copy hereof, in any land records or other appropriate records shall be conclusive as to the authority of the person designated herein to perform the functions and exercise the powers herein to perform the function and exercise the powers herein granted as to any such act performed prior to the date a modification or revocation hereof shall have been filed for the record in the appropriate records in the county wherein the land or any part thereof is situated.
