

**CERTIFICATE
OF
TRUST AGREEMENT**

Comes now REBECCA COLEMAN, pursuant to Mississippi Code Annotated of 1972 Section 91-9-7 and files this Certificate of Trust Agreement for the purpose of confirming the existence of the trust which has an ownership interest in real property. Pursuant to the above-identified statute REBECCA COLEMAN states as follows:

1. The name of the trust is the REBECCA COLEMAN REVOCABLE LIVING TRUST, dated February 9, 2006, REBECCA COLEMAN, Trustee.

Being the same property conveyed to Rebecca Coleman by deed recorded in Book 0417, Page 0373 and by deed recorded in Book 266, Page 0760 in the Chancery Clerk's Office of Desoto County, Mississippi.

5. The trust has no anticipated date of termination but shall terminate upon distribution of the assets held in trust to the named beneficiaries or upon the death of REBECCA COLEMAN.
