

SPECIAL DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That I, LORIA JEANETTE MEDLIN, of Desoto County, Mississippi, being of sound mind and memory, do hereby make, constitute and appoint my sister, BARBARA RUTH STEWART as my true and lawful agent and attorney in fact (hereinafter sometimes called "my agent"), with full power and authority to act for me and my children, Andrea Lauren Medlin and Madison Danielle Medlin, individually, and in my name, place and stead, with reference to the transaction of any and all financial business related to or connected with any of my bank accounts, including, but not limited to, the following:

Such incapacity, whether mental or physical, that I may exhibit shall not

in any way interfere with the authority of my agent herein to act fully on my behalf according to the terms hereof. In other words, this Power of Attorney shall not be affected by the subsequent disability, incompetence or incapacity of the principal.

And I do hereby undertake to ratify and confirm, all and singular, the acts heretofore performed and to be hereinafter performed by my said agents, acting in my name and on my behalf.

Banks and any other financial institutions shall honor this Power of Attorney until and unless they receive written notice of revocation of same signed by me. All banks and financial institutions are hereby indemnified and shall be held harmless by the undersigned for any and all actions taken by my agent regarding my accounts, regardless of whether within the intended scope of this Power of Attorney or not; therefore, all banks and financial institutions shall have no liability for the actions of my agent or for following the directions of my agent in connection with my bank accounts.


