AMENDED AND RESTATED MEMORANDUM OF LEASE

THIS AMENDED AND RESTATED MEMORANDUM OF LEASE is made effective as of August 1, 2007 ("Effective Date"), by and between **GE CAPITAL FRANCHISE FINANCE CORPORATION**, a Delaware corporation, with principal office and place of business at 8377 East Hartford Drive, Suite 200, Scottsdale, Arizona 85255 ("Landlord"), and **FAMOUS RECIPE COMPANY OPERATIONS, LLC**, a Georgia limited liability company, with a mailing address of 4561 Olde Perimeter Way, Unit 2706, Atlanta, Georgia 30346 ("Tenant").




