DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned, **RICHARD G. BEAN**, Social Security No. XXX-XX-2273, adult resident citizen of DeSoto County, Mississippi, residing at 5592 Southbend Lane, Olive Branch, Mississippi 38654, do hereby nominate, constitute and appoint, **JACKIE B. BEAN**, Social Security No. XXX-XX-2380, residing at 5592 Southbend Lane, Olive Branch, Mississippi 38654, as my true and lawful agent and attorney-in-fact (hereinafter called "Agent"), with full power of substitution, hereby giving and granting to said "Agent" full power and authority to act for and on my behalf and in my name, place and stead and on my behalf, individually and severally, in any and all matters in connection with my business, real property and affairs, including without limitation the following, to-wit:

1. To sign checks and any and all other orders for the payment and withdrawal of money from any and all deposits, bank accounts, savings accounts, IRA's, and certificates of deposit, of any and every nature, and to execute any agreement and undertaking with respect to any of the same, including without limitation any bond or assurance with respect to any such withdrawal; and to establish and make deposits in any and all such accounts, deposits and certificates of deposit in my name, either jointly or individually, or in the name of said Agent in said Agent's capacity as agent for me.
2. To sell and transfer any and all bonds and other securities and corporate stock standing in my name, either jointly or individually, and to execute proxies for voting of corporate stock.
3. To sell or lease any real or personal property owned by me, either jointly or individually, or in which I have any interest, wherever the same may be located, and to execute any and all deeds, bills of sale or leases for the conveyance or leasing thereof.

4. To invest any cash owned by me standing in my name, either jointly or individually, or in the name of said Agent in any securities, stock, certificates of deposit, and real and personal property, and to take and register the same in my name or in the name of said Agent as agent for me.

5. To receive, receipt for and give acquittance and release for any and all monies, properties, rights and proceeds which I may own, either jointly or individually, or in which I may have any interest or in which I may claim any ownership or interest.

6. To prepare and execute any and all income tax returns to any governmental authority and any and all instruments and papers connected therewith, including without limitation any estimates, agreements for extension or settlement, and any claim for refund.

7. To employ for me and in my behalf, or on behalf of said Agent with respect to any transaction of business or affairs for me, any Attorney, CPA, or other professional.

8. To execute any and all instruments and papers of any and every kind that may be necessary or proper in connection with any retirement benefits to which I may be entitled whether from any governmental authority or otherwise.

9. To incur and to discharge indebtedness for any of the following matters when my said Agent deem it appropriate so to do: for household or living expenses, utilities, food, drugs, clothing, recreation, travel and transportation, services of one or more domestics, services of one or more nurses or companions, services of physicians or other professional persons, for board, lodging, hospitalization, and accommodations of care institutions of every type, and for taxes due to any governmental authority.

10. And generally to do any and all acts on my behalf and to execute any and all other instruments and documents of any and every kind whatsoever in my name, place and stead whether or not such acts or such instruments and documents may be similar to those enumerated hereinabove.

This Power of Attorney shall not be affected by my disability, incompetency or incapacity but shall continue in full force and effect.

Any and every person dealing with or accepting and relying upon any instrument executed or any act taken by said Agent under the provisions of this Power of Attorney prior to actual receipt of any written notice from me that the powers conferred herein or any of them have been revoked, amended or restricted, shall be fully protected against any claims or contention by me or by my personal representatives, heirs, next of kin and assigns with respect to their right to rely upon the existence and continuing effect of this Power of Attorney and all provisions herein regardless of any lapse of time from and after the date of execution hereof. And further, if this Power of Attorney shall be recorded in the Chancery Clerk's office of DeSoto County, Mississippi, then any person or party may rely upon the authority of said Agent herein set forth as continuing to be in full force and effect unless set forth as continuing to be in full force and effect until a revocation of said Power of Attorney shall be recorded in the Chancery Clerk's office of DeSoto County, Mississippi. This instrument is executed in several counter-parts, each of which shall be deemed an original. This Power of Attorney shall not be affected by the subsequent incompetence of the principal.

This Power of Attorney is intended to allow the Agent above listed to act for and on behalf of the Principal.


