

LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

I, Amy Dunlap Totaro, of 1190 Middle Buster Street, Hernando, Mississippi, being over the age of twenty-one (21) years and of sound mind, do hereby make, constitute, and appoint Christy McMillan Girner as my true and lawful agent and attorney in fact, and do hereby confer upon her full power and authority to do and perform for me, and in my name, place, and stead, any and all acts and things requisite and necessary to be done in and about the premises, which I might or could do if personally present and acting specifically concerning signing and endorsing checks, withdrawal requests, and to pay all sums of money, at any time, or times that may hereafter be owing by me, upon any bill of exchange, check, draft, note or trade acceptance made, executed, endorsed, accepted and delivered by me, or for me, and in my name as my attorney in fact may determine. This authority is granted solely to the account established at First Security Bank, Batesville, Mississippi, bearing the name Amy Dunlap Totaro c/o Christy McMillan Girner. Said account was opened in March, 2008.

The power and authority hereby conferred upon my said agent and attorney in fact shall be limited to the duties described above.

Amy Dunlap Totaro shall not have any access to said account. The authority to make all transactions is hereby conferred upon Christy McMillan Girner.

Amy Dunlap Totaro agrees that from and after the date of this Power of Attorney, she will defend, reimburse, indemnify and hold harmless Christy McMillan Girner, Dunlap and Kyle Company, Inc., Gateway Tire and Service Center and/or their affiliates, from and against any claims, losses, liabilities and expenses including reasonable attorneys' fees, arising out of or otherwise related to the operation of the bank account and activities of the attorney in fact.

This Power of Attorney shall not be affected by subsequent disability or incapacity of the principal, or lapse of time.


