

DURABLE FINANCIAL POWER OF ATTORNEY

I, Danny McGee Owens of 3901 Klein Boulevard, Lompoc, Calif., hereby appoint Blake McGee Owens to serve as my Agent ("Agent") and to exercise the powers set forth below. This Power of Attorney shall be effective immediately upon the date of execution. This Power of Attorney shall not be affected by my disability, incompetence or death subsequent to the execution of this power.


