

SPECIFIC POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, **Bradley S. Peebles, d/b/a B.S.P. Investments, P.O. This power of attorney, by these presents conferred, shall remain in full force and effect until such time that the property described as **Lot 172, Section D, Apple Creek North Subdivision, in Section 3, Township 2 South, Range 8 West, DeSoto County, Mississippi, as shown on plat recorded in Plat Book 53, page 26, in the office of the Chancery Clerk of DeSoto County, Mississippi,** is sold, after


