GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS That I, the undersigned, **EDWARD BERNARD O'KEEFE**, an adult resident citizen of Desoto County, Mississippi, have made, constituted and appointed, and do hereby make, constitute and appoint **ARLENE SUE LeBLANC**, an adult resident citizen of Desoto County, Mississippi with her address being 845 Box Corner road in Byhalia, Mississippi, telephone number (313) 204-0401, as my true and lawful Attorney for me and in my name, place and stead, for my use and benefit, to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, legacies, bequests, interest, dividends, annuities, and demands whatsoever as are now or shall hereafter become due, owing, payable or belonging to me; to have, use and take all lawful ways and means in my name or otherwise for the recovery thereof by attachments, arrests, distress or otherwise, and to compromise and agree for the same, and acquittals or other sufficient discharges for the same; for me in my namesake, make, seal and deliver; to bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments, and accept the seizing and possession of all lands, deeds and other assurances in the law therefore; to lease, let, demise, bargain, sell, remise, release, convey, mortgage and hypothecate lands, tenements and hereditaments upon such terms and conditions and under such covenants as she may think fit. Also to bargain and agree for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods, wares and merchandise, chooses in action and other property in possession or in action, and to make, do and transact all and every kind of business of whatsoever nature and kind also in my name and as my act and deed to sign, deal, execute, deliver and acknowledge such deeds, leases and assignments of leases, covenants, indentures, agreements,

mortgages, hypothecation's, bills of lading, bills, bonds, notes, receipts, evidence of debts, releases and satisfactions of mortgages, judgments and other debts, and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises.

I give and grant unto my said Attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes as I might do if personally present. Further, if for any reason the principal herein shall be declared incompetent and/or rendered disabled during the existence of such power of attorney, then such disability and/or incompetence shall in no wise affect those powers granted hereunder.

THIS POWER OF ATTORNEY IS EFFECTIVE AS OF THE DATE NOTED BELOW AND HEREBY REVOKES ANY AND ALL OTHER POWERS OF ATTORNEY EXECUTED BY ME.


