ASSIGNMENT OF INTEREST IN MOTOR FUEL DISTRIBUTION AND  
LEASE AGREEMENT AND BILL OF SALE

WHEREAS, on February 6, 2001, SHERMAN EDWARD MORROW and DONALD F. SMITH [as "Distributor"], and CARL D. STANFORD and wife, JEAN S. STANFORD [as "Occupant" and "Owner"] [hereinafter referred to jointly and severally as "STANFORD"] entered into that certain Motor Fuel Distribution and Lease Agreement ["Agreement"] which Agreement is recorded in Book 88 at Page 403 in the Office of the Chancery Clerk of DeSoto County, Mississippi; and

WHEREAS, SHERMAN EDWARD MORROW died on December 24, 2007, and left surviving him as his sole heirs-at-law and beneficiaries his widow, BETTY MORROW, and two (2) adult children, namely: TEDDY MORROW and TIM MORROW, all of whom have succeeded to the right, title and interest of SHERMAN EDWARD MORROW in and to said Agreement; and

WHEREAS, BETTY MORROW, TEDDY MORROW, and TIM MORROW desire to assign their interest in the Agreement and in the equipment identified therein to SUMMER SMITH.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned covenant, contract, and agree as follows:

BETTY MORROW, TEDDY MORROW and TIM MORROW, jointly and severally, do hereby assign to SUMMER SMITH all of our right, title, and interest in and to the aforesaid Motor Fuel Distribution and Lease Agreement.

The undersigned BETTY MORROW, TEDDY MORROW, and TIM MORROW, jointly and severally, do hereby convey, transfer, and deliver to SUMMER SMITH, all of our right, title and interest in and to the equipment identified in the said Agreement, namely: one (1) lighted canopy, two (2) dispensers, two (2) above ground tanks (one (1) 12,000 gallon and one (1) 4,000 gallon), all plumbing, wiring, and installation, and a Ruby console.

The effective date of this instrument is August 1, 2009.




