RELEASE OF MORTGAGES AND ASSIGNMENT AGREEMENTS

This **RELEASE OF MORTGAGES AND ASSIGNMENT AGREEMENTS** (hereinafter called this "Release"), dated as of October 20, 2009, is made by the **UNITED STATES OF AMERICA** (the "Government"), acting by and through the Administrator of the Rural Utilities Service, as successor to the Rural Electrification Administration ("RUS"), **NATIONAL RURAL UTILITIES COOPERATIVE FINANCE CORPORATION** ("CFC"), acting in its individual capacity, in its capacity as agent for the PCB Trustees with respect to the Existing Mortgage (as such terms are hereinafter defined), in its capacity as guarantor of the Series 1985G Bonds and the Series 2007A Bonds (as such terms are hereinafter defined), and in any other capacity in which CFC may have rights under or with respect to the Existing Mortgage (as hereinafter defined), and **COBANK, ACB** ("CoBank," and together with the Government, acting by and through the Administrator of RUS, CFC, acting individually and in all the other capacities described above, collectively, the "Consenting Mortgagees") to **SOUTH MISSISSIPPI ELECTRIC POWER ASSOCIATION** (the "Company").

WHEREAS, certain of the Company's indebtedness is secured under one or more of the following mortgage instruments (such mortgage instruments, together with any predecessor instruments thereto and identified therein, collectively, the "Existing Mortgage"):

1. Supplement No. 2, dated as of March 1, 2007, to Supplement, dated as of July 3, 2000, to Restated and Consolidated Mortgage and Security Agreement, among the Company, as mortgagor, and the Government, acting by and through the Administrator of the RUS, CFC and CoBank, as mortgagees (the "2007 Mortgage");

7. Supplemental Mortgage and Security Agreement, dated as of July 30, 1984, among the Company, as mortgagor, and the Government, acting by and through the Administrator of the RUS, CFC and CoBank (as successor to New Orleans Bank for Cooperatives), as mortgagees;
8. Supplement to Supplemental Mortgage and Security Agreement Mortgage, dated as of October 2, 1980, between the Company, as mortgagor, and the Government, acting by and through the Administrator of the RUS, and CFC, as mortgagees;
9. Supplement to Supplemental Mortgage and Security Agreement, dated as of March 31, 1980, among the Company, as mortgagor, and the Government, acting by and through the Administrator of the RUS, and CFC, as mortgagees;
10. Supplemental Mortgage and Security Agreement, dated as of November 1, 1977, between the Company, as mortgagor, and the Government, acting by and through the Administrator of the RUS, and CFC, as mortgagees;
11. Supplemental Mortgage, dated as of July 20, 1977, between the Company, as mortgagor, and the Government, acting by and through the Administrator of the RUS, as mortgagee;

12. Mortgage, dated as of September 18, 1974, between the Company, as mortgagor, and the Government, acting by and through the Administrator of the RUS, as mortgagee;
13. Supplement to Supplemental Indenture, dated as of September 19, 1973 between the Company, as mortgagor, and Deposit Guaranty Bank and Trust Company, as Trustee;
14. Supplemental Indenture, dated as of May 26, 1971 between the Company, as mortgagor, and Deposit Guaranty Bank and Trust Company, as Trustee;
15. Supplement to Supplemental Indenture, dated as of July 12, 1966 between the Company, as mortgagor, and Deposit Guaranty Bank and Trust Company, as Trustee;
16. Supplemental Indenture, dated as of July 21, 1961, between the Company, as mortgagor, and Deposit Guaranty Bank and Trust Company, as Trustee; and
17. Indenture, dated as of July 29, 1958, between the Company, as mortgagor, and Deposit Guaranty Bank and Trust Company, as Trustee; and

WHEREAS, all or some of the instruments comprising the Existing Mortgage have been recorded in the real property records in the counties specified on Exhibit A attached hereto and hereby made a part hereof (with recording information for certain of such instruments also identified on Exhibit A); and

WHEREAS, the Company has certain existing indebtedness to each of the Government, acting by and through the Administrator of the RUS, CFC, acting in its individual capacity, and CoBank, which indebtedness is evidenced by notes secured under the Existing Mortgage; and

WHEREAS, the Company is the obligor with respect to those certain outstanding Claiborne County, Mississippi National Rural Utilities Cooperative Finance Corporation Guaranteed Floating/Fixed Rate Pollution Control Revenue Bonds (South Mississippi Electric Power Association Project) Pooled Series 1985G (the "Series 1985G Bonds"). The Series 1985G Bonds were issued under that certain Indenture of Trust, dated as of December 1, 1985 (the "1985G Bond Indenture") between Claiborne County, Mississippi (the "1985G Issuer") and U.S. Bank National Association, as successor to Morgan Guaranty Trust Company of New York, as bond trustee (the "1985G Bond Trustee"). The Series 1985G Bonds were also secured by and subject to the provisions of the Pool Indenture, dated as of December 15, 1983, as from time to time supplemented and amended (the "Pool Indenture"), among CFC, the various bond trustees and Deutsche Bank Trust Company Americas, formerly known as Bankers Trust Company, as pool trustee (the "Pool Trustee"), as supplemented by a Series 1985G Supplemental Indenture to Pool Indenture, dated as of December 15, 1985, among CFC, the 1985G Bond Trustee and the Pool Trustee. The 1985G Bond Trustee and the Pool Trustee are collectively referred to herein as the "1985G Trustees"; and

WHEREAS, pursuant to a Guaranty, Assignment and Agency Agreement, dated as of November 15, 1985 (the "1985G Assignment Agreement"), between CFC and the 1985G Trustees (i) CFC unconditionally guarantees to the 1985G Trustees for the benefit of the 1985G Issuer and the holders from time to time of the 1985G Bonds and other pooled bonds, the payments of amounts due with respect to the 1985G Bonds, (ii) CFC assigned and delivered to the 1985G Trustees, the "Project Note" (as defined in the 1985G Bond Indenture) (the "1985G Project Note") and, to the extent it secured the 1985G Project Note, an interest under the Existing Mortgage, and (iii) the 1985G Trustees appointed CFC as its agent for the purpose of serving as mortgagee under the Existing Mortgage with respect to the 1985G Project Note; and

WHEREAS, the Company is the obligor with respect to those certain outstanding Mississippi Business Finance Corporation Gulf Opportunity Zone Bonds (South Mississippi Electric Power Association Project) Series 2007A (the "Series 2007A Bonds"), which are guaranteed by CFC. The Series 2007A Bonds were issued under that certain Indenture of Trust, dated as of March 1, 2007 (the "2007A Bond Indenture"), between Mississippi Business Finance Corporation ("MBFC"), as issuer, and Trustmark National Bank, as bond trustee (the "2007A Bond Trustee"); and

WHEREAS, pursuant to a Guaranty, Assignment and Agency Agreement, dated as of March 1, 2007 (the "2007A Assignment Agreement"), between CFC and the 2007A Bond Trustee (i) CFC unconditionally guaranteed to the 2007A Bond Trustee for the benefit of the issuer of the 2007A Bonds and the holders from time to time of the 2007A Bonds, the payments of amounts due with respect to the 2007A Bonds, (ii) CFC assigned and delivered to the 2007A Bond Trustee, the "Project Note" (as defined in the 2007A Bond Indenture) (the "2007A Project Note") and, to the extent it secured the 2007A Project Note, an interest under the Existing Mortgage; and (iii) the 2007A Bond Trustee appointed CFC as its agent for the purpose of serving as mortgagee under the Existing Mortgage with respect to the 2007A Project Note; and

WHEREAS, the Company is the obligor with respect to those certain outstanding Mississippi Business Finance Corporation Gulf Opportunity Zone Bonds (South Mississippi Electric Power Association Project) Series 2007B (the "Series 2007B Bonds"). The Series 2007B Bonds were issued under that certain Indenture of Trust, dated as of March 1, 2007 (the "2007B Bond Indenture"), between MBFC and Trustmark National Bank, as bond trustee (the "2007B Bond Trustee," and together with the 2007A Bond Trustee and the 1985G Trustees, collectively, the "PCB Trustees"); and

WHEREAS, pursuant to an Assignment and Agency Agreement, dated as of March 1, 2007 (the "2007B Assignment Agreement"), between CFC and the 2007B Bond Trustee (i) CFC assigned and delivered to the 2007B Bond Trustee, the "Project Note" (as defined in the 2007B Bond Indenture) (the "2007B Project Note"), and, to the extent it secured the 2007B Project Note, an interest under the Existing Mortgage, and (ii) the 2007B Bond Trustee appointed CFC as its agent for the purpose of serving as mortgagee under the Existing Mortgage with respect to the 2007B Project Note; and

WHEREAS, the 2007A Assignment Agreement and the 2007B Assignment Agreement have been recorded in the real property records in the counties specified on Exhibit B attached hereto and hereby made a part hereof (with recording information for such instruments also identified on Exhibit B); and

WHEREAS, with the consent of the Consenting Mortgagees, simultaneously with the delivery of this Release, the Existing Mortgage is being replaced and substituted for by that certain Indenture of Deed of Trust, Security Agreement and Financing Statement, dated as of September 1, 2009, made by the Company to U.S. Bank National Association, Trustee (the "Indenture"); and

WHEREAS, simultaneously with the delivery of this Release, (i) the 2007A Bonds are being defeased and are no longer "Outstanding" (as defined in the 2007A Bond Indenture) and (ii) the 2007B Bonds are being redeemed and are no longer "Outstanding" (as defined in the 2007B Bond Indenture); and

WHEREAS, in connection with the substitution of the Indenture for the Existing Mortgage, the Company has requested that the Consenting Mortgagees release and discharge of record any and all rights, titles, liens and interests of the Consenting Mortgagees in any and all property of the Company (the "Company Property"), including, without limitation, all property and interests specifically described in the Existing Mortgage.

NOW, THEREFORE, THESE PRESENTS WITNESSETH that, in consideration of the sum of one dollar in hand paid by the Company to the Consenting Mortgagees at the time of delivery of these presents and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the Consenting Mortgagees hereby **CONVEYS AND QUITCLAIMS** to the Company all of its rights, titles, liens and interests in the Company Property, under or by virtue of the Existing Mortgage or otherwise, and hereby **RELEASES AND DISCHARGES OF RECORD** any and all of its rights, titles, liens and interests in the Company Property, under or by virtue of the Existing Mortgage or otherwise.

The effect of this Release shall be that any and all rights, titles, liens and interests of each of the Consenting Mortgagees in the Company Property, under or by virtue of the Existing Mortgage or otherwise, whether recorded or filed or not, are hereby released. It is the intention of each of the Consenting Mortgagees that all such rights, titles, liens and interests in the Company Property shall be discharged of record and to that end each of the Consenting Mortgagees hereby authorizes and requests the recorder of deeds of each county in which this Release is recorded to mark satisfied, discharged and released of record any Existing Mortgage or other recorded lien in favor of any of the Consenting Mortgagees, whether or not listed on Exhibit A.

CFC, acting in its capacities as guarantor of the 2007A Bonds, as agent of the 2007A Bond Trustee, and as agent of the 2007B Bond Trustee, also hereby authorizes and requests the recorder of deeds of each county in which this Release is recorded to mark satisfied, discharged and released of record on each of the 2007A Assignment Agreement and the 2007B Assignment Agreement.

THIS RELEASE SHALL NOT IN ANY WAY AFFECT OR IMPAIR ANY SECURITY TITLE, LIEN OR INTEREST OF ANY OF THE CONSENTING MORTGAGEES IN THE COMPANY PROPERTY BY VIRTUE OF THE INDENTURE.

This Release is made by the Consenting Mortgagees without covenant or warranty, express or implied, at law or in equity, and without recourse to the Consenting Mortgagees in any event or in any contingency.

This Release may be executed in any number of counterparts, and all said counterparts executed and delivered, each as an original, shall constitute but one and the same instrument, except that Exhibit A attached hereto may reflect the recording information for the Existing Mortgage only for the county in which this Release is filed.
