DURABLE POWER OF ATTORNEY


KNOW ALL MEN BY THESE PRESENTS: That I, OPAL L. STOKES, an adult, residing at 8755 Greenbrook Parkway, Southaven, MS 38671, do hereby name constitute and appoint BOBBIE GEATER, residing at 5295 Plum Tree Drive, Southaven, MS 38671, to be my true and lawful attorney-in-fact for me and in my name, place and stead, to perform any and all acts and to do any and all things whatsoever regarding my person and my property, real, personal or mixed, in the same manner and to the same extent as I might personally do and perform including but not limited to, the right to deposit and withdraw money and funds from savings and/or checking accounts now or hereafter maintained by me in my sole name, to pay or otherwise discharge any debts and accounts created by me or for my use and benefit, to pay any sums due and owing or contracted to be paid by me in monthly installments or otherwise including, but not limited to, rents, mortgage payments, retail installment contract payments, to accept and give receipt and/or acquittance for payments due and owing to me or for my benefit and to deposit the same into either checking or savings accounts maintained by me and to sell, mortgage, convey, pledge, contract for the future sale of or to rent or lease any property, real or personal, owned by me for any price or rental and upon any terms or conditions

which shall, in the sole discretion of my said attorney-in-fact, be deemed to be proper and to my best interest and/or advantage. In addition to the powers hereby granted to my said attorney-in-fact, it is my intention that the said attorney-in-fact shall have and assume for and on behalf of me each, all and every right and privilege which might personally have and/or assume regardless of whether the same shall be specifically set forth or defined herein and shall have the right to act in my name and stead for all purposes and intents as though I were present. This power includes but is not limited to the power to buy, sell, transfer and assign securities.

This agency and the powers and rights hereby created by and conferred in my attorney-in-fact shall continue in full force and effect through the remainder of my lifetime or until cancelled/renounced in writing by me or until my attorney-in-fact shall resign or shall certify his/her inability or unwillingness to serve by written notice to me. This power of attorney shall not be affected by my subsequent disability or incompetence. Nevertheless, should my attorney-in-fact predecease me, then in such event, this appointment shall become null and void and of no further force and effect and the powers hereby granted shall automatically cease to exist.




