This durable power of attorney shall not be affected by any disability on my part, except as provided by the statutes of the State of Mississippi. The above grant of power is intended to be as broad as possible so that my attorney-in-fact will have authority to make any decision I could make to obtain or terminate any type of health care, including the withdrawal of food and water and other life-sustaining measures, if my attorney-in-fact believes such action would be consistent with my intent and desires.

All acts done by my attorney-in-fact pursuant to the power conferred by this instrument during any period of my disability shall have the same effect and inure to the benefit of and bind me or my heirs, devisees and personal representatives as I were not disabled.

This durable power of attorney shall be nondelegable and shall be valid until such time as I die or revoke this power by subsequent written instrument.
