

7. The Successor Trustees are: 1st) LAURA WILFONG MILLER; 2nd) LISA POOLE HOOTEN.


8. You are authorized to accept orders and other instructions from any of the Trustees or Successor Trustees.

11. The undersigned agree to inform you in writing of any amendment to the trust, and change in the composition of the Trustees or any other event which could materially alter this certification.


