

5. Title to assets held in the trust shall be titled as:
SUSAN ROSTECK HURLEIGH, Trustee of the SUSAN ROSTECK HURLEIGH Living Trust dated April 13, 2011, and any amendments thereto.
6. Any alternative description shall be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
7. Excerpts from the trust agreement that establish the trust, designate the Trustee and set forth the powers of the Trustee will be provided upon request. The powers of the Trustees include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage and deal with real and personal property interests.
8. The terms of the trust agreement provide that a third party may rely upon this Certification of Trust as evidence of the existence of the trust and is specifically relieved of any obligation to inquire into the terms of this agreement or the authority of my Trustee, or to see to the application that my Trustee makes of funds or other property received by my Trustee.
9. The trust has not been revoked, modified or amended in any way that would cause the representations in this Certification of Trust to be incorrect.
10. The term of the trust is dependent upon one or more lives and therefore cannot be determined at this time.
11. The general powers granted to the Trustees (including any successor Trustee) includes, but are not limited to, all of the powers granted to the Trustees under the laws of the state governing this trust including the right to sell real property at private sale without court order.
12. Any real property owned by the trust is described in Exhibit A to this Certification of Trust. This Certification of Trust may be used in lieu of the entire trust agreement for filing in the land records of the appropriate county pursuant to Section 91-9-7 of the Mississippi Code Annotated, as amended.
