


EXHIBIT "A"

Part of the Southeast Quarter of Section 1, Township 3 South, Range 6 West, DeSoto County, Mississippi, and more particularly described as follows: to-wit:

Commencing at a point on the centerline of Byhalia Road a distance of 861.1 feet east of, as measured along said road centerline, a point commonly accepted as the northeast corner of said quarter section; thence run south 00 deg. 25 min. 53 sec. East a distance of 43.02 feet to a point on the south right-of-way line of said road (80 feet wide) said point being the Point of Beginning and the northeast corner of the Lipscomb property; thence run South 82 deg 38 min 57 sec East a distance of 300.0 feet along said south right-of-way line to a half-inch steel bar; thence run south 01 deg 30 min 47 sec west a distance of 1585.11 feet to half-inch steel bar; thence run South 86 deg 53 min 03 sec west a distance of 243.72 feet to a half-inch steel bar; thence run North 00 deg 25 min 53 sec West a distance of 1959.15 feet to the Point of Beginning and containing 10.00 acres. Bearings are based on true north as determined by solar observation.
