**CERTIFICATE OF TRUST FOR THE MCGRORY LIVING TRUST

2. The Trustees of the trust are James G. McGrory and Gladys E. McGrory.

4. Title to assets held in the trust shall be titled as:  



6. Excerpts from the trust agreement that establish the trust, designate the Trustee and set forth the powers of the Trustee will be provided upon request. The powers of the Trustees include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage and deal with real and personal property interests.
  7. The terms of the trust agreement provide that a third party may rely upon this Certificate of Trust as evidence of the existence of the trust and is specifically relieved of any obligation to inquire into the terms of this agreement or the authority of my Trustee, or to see to the application that my Trustee makes of funds or other property received by my Trustee. The term of the trust is undeterminable at this time because the trust is revocable and further because the term is based on the life of one or more individuals.
  8. The trust has not been revoked, modified or amended in any way that would cause the representations in this Certification of Trust to be incorrect. The trust currently owns or is anticipated to own the real property described in composite Exhibit A to this Certificate, the legal description of which is incorporated into this Certificate by reference.
  9. During the lifetime of either of the Grantors, James G. McGrory and Gladys E. McGrory have the beneficial right to use, occupy, and reside in any real property described in Exhibit A.


