


6. The general powers granted to the trustee(s):






EXHIBIT 'A'

Trace 2: Part of the Northeast Quarter of the Northwest Quarter of Section 18, Township 2 South, Range 8 West, DeSoto County, Mississippi and being more particularly described as follows, to-wit:

Commencing at a point commonly accepted as the Northeast Quarter of said Section 18, said point being in the intersection of Austin Rd & Fogg Rd; thence run South 89 degrees 38 minutes 14 seconds West a distance of 3035.18 feet to a point; thence run South 00 degrees 42 minutes 18 seconds East a distance of 47.18 feet to the Point of Beginning; thence run South 00 degrees 31 minutes 39 seconds East a distance of 491.80 feet to a point; thence run South 89 degrees 28 minutes 21 seconds West a distance of 283.84 feet to a point; thence run North 00 degrees 31 minutes 39 seconds West a distance of 494.21 feet to a point; thence run South 89 degrees 56 minutes 06 seconds East a distance of 41.06 feet to a point; thence run South 89 degrees 16 minutes 48 seconds East a distance of 170.26 feet to a point; thence run North 88 degrees 07 minutes 01 seconds East a distance of 72.54 feet to the Point of Beginning and containing 3.20 acres.
