



LEGAL DESCRIPTION


DANCY - HORN LAKE 1 LOT NO. 2  
BEING LOCATED IN THE SOUTHEAST QUARTER  
SECTION 27, TOWNSHIP 1 SOUTH, RANGE 8 WEST  
HORN LAKE, DESOTO COUNTY, MISSISSIPPI

Beginning at an iron stake in the northerly line of Goodman Road, said iron stake being 294.00 feet eastwardly and 40.00 feet northwardly from the southwest corner of the southeast quarter of Section 27, Township 1 South, Range 8 West; thence North 88 degrees 18 minutes 08 seconds East 100.00 feet with the northerly line of Goodman Road to an iron stake; thence North 01 degrees 28 minutes 30 seconds West 200.00 feet to an iron stake; thence South 88 degrees 18 minutes 08 seconds West 100.00 feet to an iron stake at the northeast corner of the Dancy - Horn Lake 1 Lot Tract; thence South 01 degrees 28 minutes 30 seconds East 200.00 feet along said tract to the point of beginning containing 0.46 acres of land being subject to all codes, easements and right-of-ways of record.
