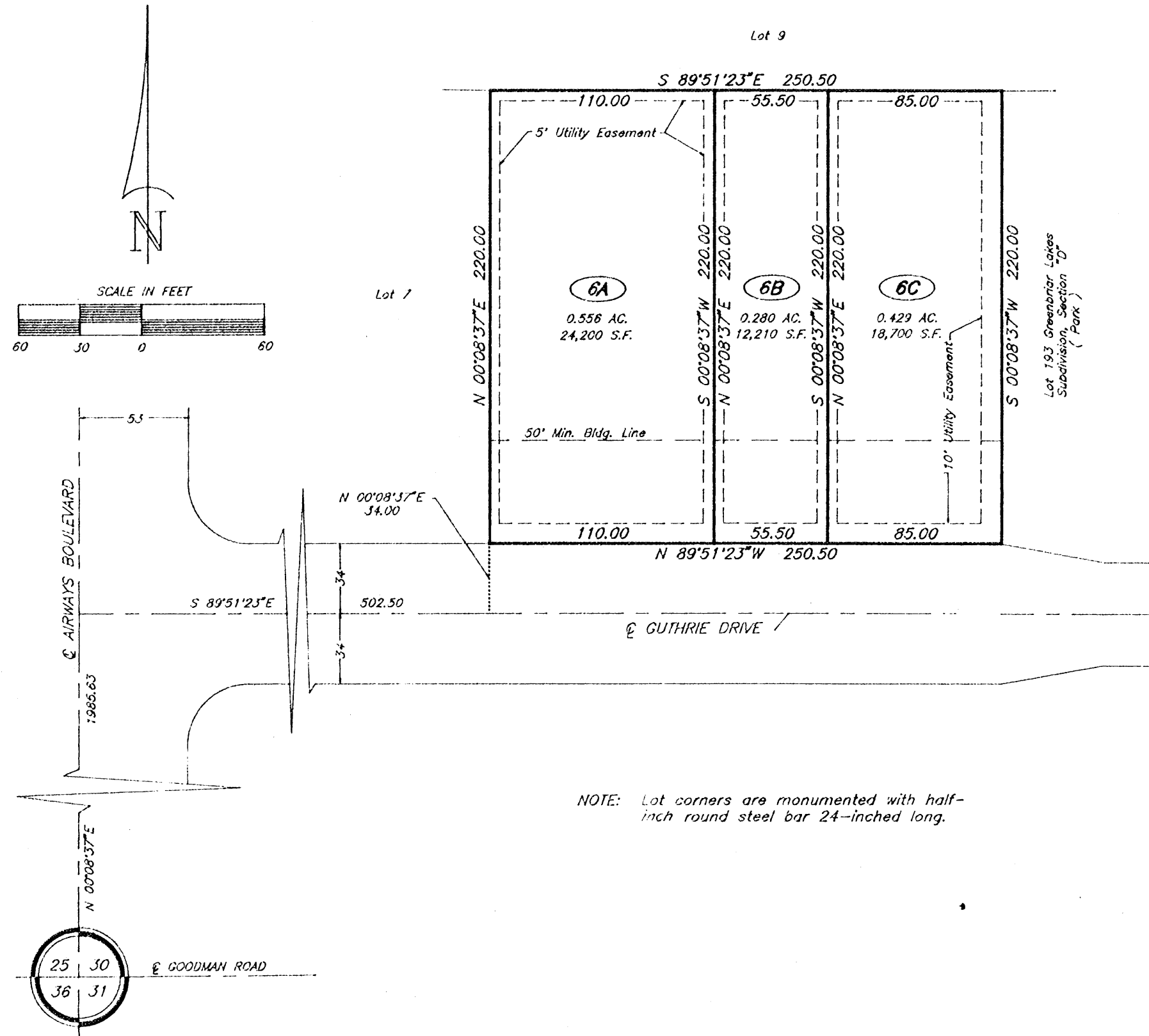


FIRST REVISION TO LOT 6 OF AIRWAYS COMMERCIAL CENTER S/D

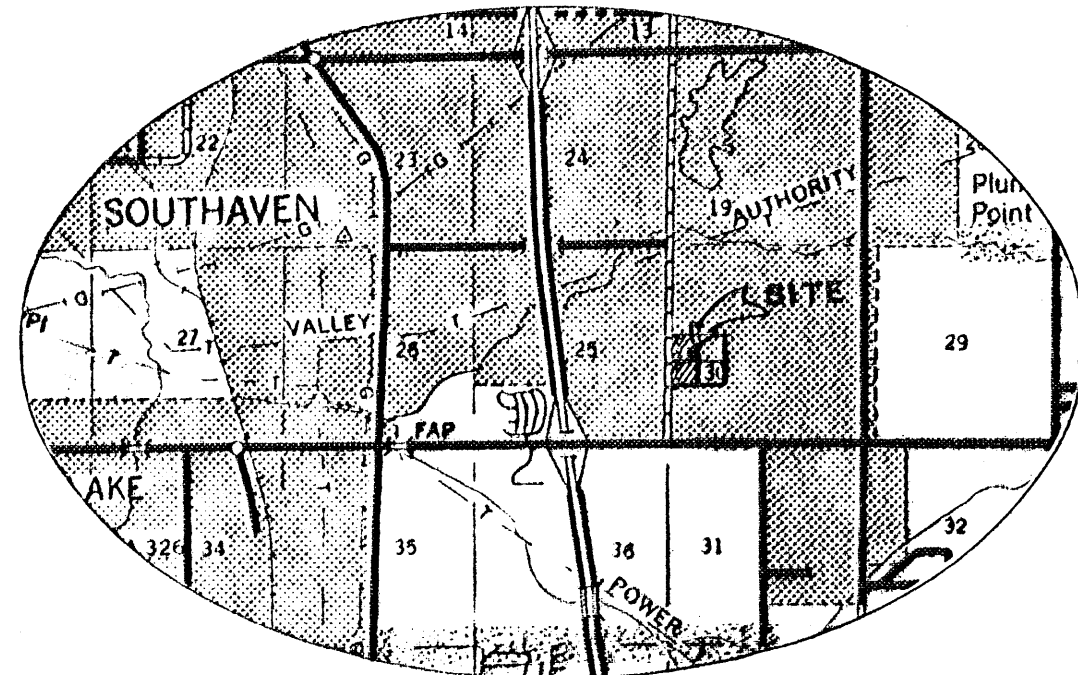
LEGAL DESCRIPTION:

Lot 6 of Airways Commercial Center S/D, First Revision, being part of the Southwest Quarter of Section 30, Township 1 South, Range 7 West, DeSoto County, Mississippi, and more particularly described as follows, to-wit:

Commencing at a cotton picker spindle at the intersection of the centerlines of Mississippi Highway No. 302 (Goodman Road) and Airways Boulevard, said point being commonly accepted as the southwest corner of said quarter section; thence run North 00°08'37" East a distance of 1985.63 feet along said centerline of Airways Boulevard to its intersection with the centerline of Guthrie Drive; thence run South 89°51'23" East a distance of 502.50 feet along said centerline of Guthrie Drive to a point; thence run North 00°08'37" East a distance of 34.00 feet to a point on the north right-of-way line of said Guthrie Drive, said point being the southeast corner of Lot 7 of said subdivision and the Point of Beginning; thence North 00°08'37" East a distance of 220.00 feet along the east line of said Lot 7 to the northeast corner of said Lot 7, said point being on the south line of Lot 9 of said subdivision; thence run South 89°51'23" East a distance of 250.50 feet along said south line of Lot 9 to the southeast corner of said Lot 9, said point being on the west line of Lot 192 of Greenbar Lakes Subdivision; thence run South 00°08'37" West a distance of 220.00 feet along said west line of Lot 192 to the southwest corner of said Lot 192, said point being on said north right-of-way line of Guthrie Drive; thence run North 89°51'23" West a distance of 250.50 feet along said north right-of-way line to the Point of Beginning and containing 1.26 acres (55,110 square feet). Bearings are based on calls shown on plat of Airways Commercial Center S/D, First Revision.



NOTE: Lot corners are monumented with half-inch round steel bar 24-inches long.

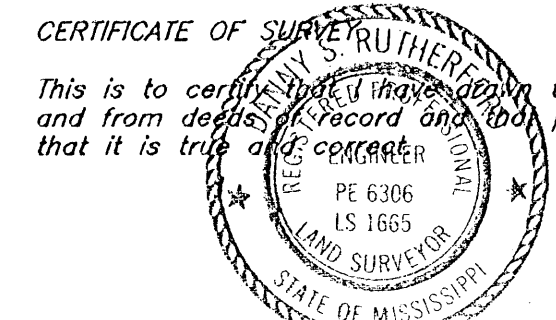
