





Part of Hernando Town Lot 384 in the Northwest quarter of Section 13, Township 3 South, Range 8 West, DeSoto County, Mississippi, more particularly described as BEGINNING at the Northwest corner of Hernando Town Lot 384 as shown on the official map of the Town of Hernando on file in the office of the Chancery Clerk of DeSoto County, said point being on the South right-of-way line of Robinson Road (40 feet wide); thence run Easterly a distance of 116.56 feet along said right-of-way line, a curve to the left with a radius of 369.79 feet, to a point; thence run North 85 degrees 17 minutes 17 seconds East a distance of 55.44 feet along said right-of-way line to a point; thence run South 03 degrees 50 minutes 49 seconds East a distance of 150.0 feet to a point on the South line of the North half of said Town Lot 386; thence run South 89 degrees 39 minutes 55 seconds West a distance of 184 feet along said South line of North half of said Town Lot 384 to a point on the East right-of-way line of an abandoned street; thence run North 01 degrees 02 minutes 27 seconds East a distance of 150.67 feet along said East right-of-way line to the point of beginning and containing 0.60 acre.
