





LIMITED POWER OF ATTORNEY

Reference is made to Purchase and Sale Agreement ("Agreement") executed and delivered on August 28, 2002, by and between First Tennessee Bank National Association, including its division, First Horizon Money Center ("Seller") and American General Finance, Inc. ("Buyer").


