A 2.9891. more or less. acre tract of land being located in the Southwest Quarter of Section 17. Township 3 South, Range 7 West, DeSoto County, Mississippi, being further described by metes and bounds as follows: Begin at an iron stake (found) at the accepted southeast corner of the southwest quarter of Section 17, Township 3 South, Range 7 West, said stake being also the northerly line of Holly Springs Road; thence North 90 deg. 00 min. 00 sec. West 312.67 feet with the southerly line of said section and along the northerly line of said road to a wooden stake (found-iron stake set) at the southeast corner of the Douglas W. Morris tract; thence North 00 deg. 13 min. 59 sec. East 417.29 feet along the easterly line of said Morris tract to a wooden stake (found-iron stake set); thence North 89 deg. 57 min. 36 sec. East 311.24 feet to an iron stake (set) in the easterly line of the southwest quarter of said section; thence South 00 deg. 02 min. 15 sec. 
