



The undersigned LINDA JOHNSON, Vice President of HOUSEHOLD FINANCE CORPORATION II duly sworn, upon oath, states as follows:



6. To-wit this affidavit is executed by a Vice President of HOUSEHOLD FINANCE CORPORATION II and the corporate seal of affixed.


