

## LEGAL DESCRIPTION

Land in DeSoto County, Mississippi, described as follows, to wit:

Part of the Northeast Quarter of Section 29, Township 1 South, Range 8 West, more particularly described as follows:

Commencing at a point commonly accepted as the northeast corner of said Section 29, said point being a masonry nail at the intersection of the centerlines of Horn Lake and DeSoto Roads; thence run south 00 degree 06' 56" East a distance of 1361.00 feet along the East line of said Section 29 to the point of beginning; thence continue South 00 Degree 06' 56" East a distance of 330.25 feet along said east section line to a point; thence run south 89 degree 53' 04" West a distance of 1320.00 feet to a point; thence run North 00 degree 06' 56" East a distance of 330.25 feet to a point; thence run North 89 degree 53' 04" East a distance of 1320.00 feet to the point of beginning and containing 10.01 acres. Bearings are based on grid north of the Mississippi State Plane Coordinate System, West Zone.
