

LEGAL DESCRIPTION

A parcel of land being part of the Kevin Royal Rust tract located in the northeast quarter of Section 35, Township 2 South, Range 9 West, DeSoto County, Mississippi, and being more particularly described as follows, to-wit:

Commencing at a point commonly accepted as the northeast corner of the northeast quarter of said section 35; thence north 89 degrees, 47 minutes, 19 seconds west, a distance of 2474.40 feet to the point of beginning for the following tract; thence south 00 degrees, 50 minutes 55 seconds east, a distance of 435.60 feet to an iron pin set; thence north 89 degrees, 47 minutes 06 seconds west a distance of 199.96 feet to an iron pin set; thence north 00 degrees 51 minutes 14 seconds west a distance of 435.60 feet to a point on the north line of said quarter section; thence south 89 degrees 47 minutes 06 seconds east a distance of 200.00 feet to the point of beginning, subject to existing easements, right-of-way for Dean Road, subdivision and zoning regulations in effect in DeSoto County, Mississippi.
