PARCEL II-

Being a description of part of the North Goodman Investment Company property located in Section 26, Township 1 South, Range 8 West, City of Horn Lake, DeSoto County, Mississippi, as follows: Lot 3, Fifth Revision to Sutton Place, situated in Section 26, Township 1 South, Range 8 West, City of Horn Lake, DeSoto County, Mississippi, as shown by plat appearing of record in Plat Book 60, Pages 31 and 32, in the office of the Chancery Clerk of DeSoto County, Mississippi, more particularly described as follows:

Commencing at the southeast corner of said Section 26, Township 1 South, Range 8 West, said point being in the centerline of Goodman Road (R.O.W. varies); thence south 89 degrees 16 minutes 35 seconds west along the centerline of Goodman Road a distance of 577.39 to a point, said point being 59.33 feet west of the centerline of Sutton Place Drive; thence north 0 degrees 43 minutes 25 seconds west a distance of 75.00 feet to the point of beginning, said point being in the north line of Goodman Road; thence south 89 degrees 16 minutes 35 seconds west along the north line of Goodman Road a distance of 207.50 feet to a point; thence north 0 degrees 38 minutes 38 seconds west a distance of 270.00 feet to a set iron pin; thence south 89 degrees 16 minutes 35 seconds west a distance of 215.00 feet to a set iron pin; thence south 0 degrees 38 minutes 38 seconds east a distance of 40.00 feet to a point; thence south 89 degrees 16 minutes 35 seconds west a distance of 320.00 feet to a found iron pin; thence north 0 degrees 38 minutes 38 seconds west a distance of 295.10 feet to the southwest corner of Lot 6 (Plat Book 60 Page 31 and 32); thence north 89 degrees 16 minutes 35 seconds East along the dividing line between Lot 3 and said Lot 6 a distance of 605.33 feet to a set iron pin; thence south 00 degrees 36 minutes 02 seconds east a distance of 300.77 feet to a set iron pin; thence north 89 degrees 23 minutes 58 seconds east a distance of 137.40 feet to a set iron pin; thence south 0 degrees 38 minutes 38 seconds east a distance of 224.04 feet to the point of beginning.
