

LIMITED POWER OF ATTORNEY

This Limited Power of Attorney is executed as of November 29, 2004 by WACHOVIA BANK, NATIONAL ASSOCIATION (formerly known as First Union National Bank), a national banking association with its principal place of business in Charlotte, North Carolina, hereinafter ("Wachovia") appointing as attorney-in-fact Wells Fargo Bank, N.A., successor by merger to Wells Fargo Home Mortgage, Inc. ("Servicer").

Wachovia hereby grants to the aforementioned attorneys-in-fact authority to act in any manner necessary and proper to exercise the following powers as fully as Wachovia might or could do and perform by itself for pools identified in the attached, Exhibit A :

RECITALS:

A. Servicer is performing certain servicing functions for Wachovia in connection with mortgage loans described in a certain loan servicing agreement between Wachovia and Servicer (the "Agreement").

B. In connection with Servicer's performance of such functions, Wachovia desires to empower Servicer to execute certain documents on Wachovia's behalf as further described herein.

SERVICER IS AUTHORIZED TO ACT AS ATTORNEY-IN-FACT IN THE FOLLOWING LIMITED CIRCUMSTANCES.

In the name of Wachovia To: (a) execute substitutions of trustee in deeds of trust and deeds to secure the debt; (b) execute Affidavits of Judgment; (c) execute Affidavits of Debt; (d) execute Affidavits regarding lost promissory notes; (e) execute non-military Affidavits; and (f) other documents as may be necessary and proper to provide foreclosure and other related default services as requested by Wachovia.

This limited Power of Attorney is not intended to: (a) extend the powers granted to Servicer under the Agreement; (b) to allow Servicer to take any action with respect to a mortgage loan not authorized by the Agreement; or (c) to modify security instruments.

This Limited Power of Attorney shall be effective as of November 29, 2004 and shall continue in full force and effect until revoked by Wachovia in writing delivered to Servicer and filed of record in the real property records. Wachovia and Servicer agree that any bank or other institution may rely on this Limited Power of Attorney in honoring the acts of Servicer hereunder.


