EXHIBIT "A"

Description of a 2.0 acre lot as part of the Enrikin Tract located in the Northwest Quarter of Section 22, Township 3 South, Range 7 West, DeSoto County, Mississippi, pursuant to a plat and description of J. E. Lauderdale, L.S., said plat and description are attached hereto and incorporated herein by reference.

Beginning at the northwest corner of Section 22, Township 3 South, Range 7 West; thence south 258.71 feet to a point in the center line of Getwell Road; thence east 40 feet to a point in the east right of way of said road the Point of Beginning of the following lot: thence North $85^{\circ}07'$ East 384.0 feet to a point; thence South $06^{\circ}51'$ East 235.0 feet to a point; thence South $85^{\circ}07'$ West 384.0 feet to a point in the east right of way of Getwell Road; thence North $06^{\circ}51'$ West 235.0 feet to the Point of Beginning and containing 2.0 acres more or less. All bearings are magnetic.
