AS A NOMINEE FOR COUNTRYWIDE HOME LOANS, INC., a certain Deed of Trust securing a Promissory Note in the original principal sum of \$205,321.00 and payable to the order of COUNTRYWIDE HOME LOANS, INC.; said Deed of Trust was recorded in Book 2328 at Page 659 in the Office of the Chancery Clerk of Desoto County, Mississippi, to which reference is made for a description of said Note, the terms and covenants of said Deed of Trust, and the land and premises therein conveyed; and
