



## ITEM I

I hereby direct that all my just debts, which shall be probated, registered and allowed against my estate, be paid as soon as possible after my death.

## ITEM II

I do hereby will, devise and bequeath all of my property, whether real, personal or mixed, and wherever situated, of which I may die seized and possessed to my wife, DORA OPHLIA ANGLIN, in fee simple absolute.

In the event my wife, DORA OPHLIA ANGLIN, predeceases me or her death is coincidental with mine, I hereby will, devise and bequeath all of my property, whether real, personal or mixed, and wherever situated, of which I may die seized and possessed to my children, BARRY LAMAR ANGLIN and DEBORAH GAIL ANGLIN BROWN, share and share alike.

In the event BARRY LAMAR ANGLIN and DEBORAH GAIL ANGLIN BROWN, or either of them, predecease me or their deaths are coincidental with mine, I hereby will, devise and bequeath such deceased child's share of my property, whether real, personal or mixed, and wherever situated, of which I may die seized and possessed to my grandchildren, KEVIN LAMAR BROWN and ASHLEY LYNN BROWN, share and share alike.

## ITEM III

I hereby nominate, constitute and appoint my wife, DORA OPHLIA ANGLIN, as Executrix of this Will and relieve her from making
