SUBSTITUTION OF TRUSTEE

WHEREAS, Pamela G. Jones executed a Deed of Trust dated November 23, 1999, in favor of Jeanine B. Saylor, Trustee(s), and First Trust Mortgage Company, Lender, for the benefit of the owner and holder of a certain indebtedness, First Trust Mortgage Company; and
