A 7.16, more or less, acres tract of land being located in the West half of the Southeast Quarter of the Southwest Quarter of Section 29, Township 1 South, Range 5 West of the Chickasaw Meridian, DeSoto County, Mississippi and being more particularly described as follows:

Commencing at the Southwest Corner of Section 29, Township 1 South, Range 5 West of the Chickasaw Meridian; thence North 90 degrees 00 minutes 00 seconds East, a distance of 1,483.09 feet to a point; thence North 00 degrees 00 minutes 00 seconds West, a distance of 42.50 feet to a 1/2" Iron pipe (Set) in the North right of Way line of Goodman Road (Right of Way varies); thence North 00 degrees 05 minutes 07 seconds East, a distance of 1,084.16 feet to a 1/2" Iron pipe (Set); thence South 89 degrees 54 minutes 53 seconds East, a distance of 301.50 feet to a 1/2" Iron pipe (Set); thence South 01 degrees 29 minutes 06 seconds West, a distance of 1,080.82 feet to a 1/2" Iron pipe (Set) in the North Right of way line of Goodman Road; thence along said Right of way line, South 89 degrees 19 minutes 17 seconds West, a distance of 275.12 feet to a point of beginning containing 7.16, more or less, acres and being subject to all codes, covenants, easements, revisions, restrictions, regulations and right of ways of record.
