WHEREAS, by warranty deed dated February 11, 1977, Southaven Land Company, Inc. conveyed four parcels of real estate situated in DeSoto County, Mississippi to Will Renfro, said warranty deed appearing of record in Warranty Deed Book 128, Page 229, in the Warranty Deed Records of DeSoto County, Mississippi, and

WHEREAS, there was an error contained in the legal description of parcels 1 and 4, of the aforementioned warranty deed and it is the purpose and intent of this correction warranty deed to correct the error contained in said descriptions.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00), cash in hand paid and other good and valuable considerations, the receipt of all of which is hereby acknowledged, SOUTHAVEN LAND COMPANY, INC. does hereby sell, convey and warrant unto WILL RENFRO, the following described property, lying and being situated in DeSoto County, Mississippi.

PARCEL I

7.91 acres in Section G, Greenbrook Subdivision, in Section 19, Township 1 South, Range 7 West, DeSoto County, Mississippi; BEGINNING at a point in the east line of Greenbrook Parkway 575.67 feet south of the south line of Rasco Road (produced), thence east at an interior angle of 92 degrees 36 minutes 250.60 feet to a point; thence northeastwardly at an interior angle of 159 degrees 54 minutes 433.70 feet to a point; thence northeastwardly at an interior angle of 141 degrees 11 minutes 200 feet to a point in the south line of Rasco Road; thence northwestwardly at an interior angle of 90 degrees along the south line Rasco Road 323.0 feet to a point at the beginning of a curve to the left with a radius of 568.01 feet; thence northwardly and westwardly along the arc of said curve 361.02 feet to a point; thence west along the south line of Rasco Road 154.94 feet to the beginning of a curve to the left with a radius of 30 feet; thence westwardly and southwardly along the arc of said curve 46.74 feet to a point in the east line of Greenbrook Parkway; thence south along the said east line of Greenbrook Parkway 546.05 feet to the point of beginning.

PARCEL IV

Part of the 2.088 acre church site shown on the plan of Section H, Greenbrook Subdivision, DeSoto County, Mississippi; BEGINNING at a point in the south line of Clarington Drive 231.037 feet west of the west line of Greenbrook Parkway, produced; thence south at an interior angle of 90 degrees 130 feet to a point; thence west at an interior angle of 90 degrees 160 feet to a point in the east line of Lot 1369, Section G, Greenbrook Subdivision; thence north at an interior angle of 90 degrees 130 feet to a point in the south line of Clarington Drive at the northeast corner of Lot 1370, Section H, Greenbrook Subdivision; thence east along the south line of Clarington Drive 160 feet to the point of beginning.


