FOR AND IN CONSIDERATION of the love and affection I have for the Grantee herein, I, Allie Mae Vaughn Kirk, a widow, do hereby give, convey and warrant unto Cornelia K. Vincent, the land lying and being situated in DeSoto County, Mississippi, described as follows, to wit:

TRACT 1. 10 acres in the Northeast Quarter of Section 32, Township 2, Range 6, of said County BEGINNING at a point 1,140 feet South of the Northeast corner of said Section, said point being the Southeast corner of the Gladys Algee 10-acre Lot; thence along the South line of the Gladys Algee Lot West 630 feet to a point; thence North 286.95 feet to a point; thence West 690 feet to a point being the Southwest corner of the Gladys Algee Lot; thence South 357.39 feet to a point, being the Northwest corner of the Eugene Vaughn Lot; thence along the North line of the Eugene Vaughn Lot East 690 feet to a point; thence South 229.56 feet to a point; thence East along the North line of the Eugene Vaughn Lot 630 feet to a point being the Northeast corner of the Eugene Vaughn Lot; thence North 300 feet to the point of beginning and containing 10 acres more or less

TRACT 2. 5 acres in the Northwest Quarter of the Northeast Quarter of Section 32, Township 2, Range 6, of said County BEGINNING at a point 990 feet South of the Northeast corner of the Northwest Quarter of the Northeast Quarter of said Section, being the Southeast corner of the Nora Shelton 5-acre lot; thence West along the South line of the Nora Shelton Lot 1,320 feet to a point being the Southwest corner of the Nora Shelton Lot; thence South 165 feet to a point being the Northwest corner of the Eugene Vaughn Lot; thence along the North line of the Eugene Vaughn Lot East 1,320 feet to a point being the Northeast corner of the Eugene Vaughn Lot; thence North 165 feet to the point of beginning and containing 5 acres more or less.


