For and in consideration of the sum of \$10.00, cash in hand paid, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, L. T. JOHNSON, an unmarried man, do hereby sell, convey and warrant unto BILLY R. SAXON and EDGAR M. STAFFORD, and their successors, as Trustees for the TRUE DOCTRINE CHAPEL COMMUNITY CHURCH, the following described land lying and being situated in the Southeast Quarter of Section 22, Township 2, Range 6, DeSoto County, Mississippi:

Beginning at the southwest corner of the West 140 acres of the Southeast Quarter of Section 22, Township 2, Range 6; thence East 208 feet to a stake; thence North 208 feet to a stake; thence West 208 feet to a stake; thence South 208 feet to the point of beginning, containing one acre, more or less, and being part of the lands conveyed to the Grantor by deed of record of December 26, 1936, of record in Deed Book 26, at page 36, of the land records of DeSoto County, Mississippi.


